Overview

The OTHM Level 4 Diploma in Accounting and Business at London Campus of Higher Studies - LCHS helps learners build a solid foundation in both accounting and the wider world of business. Qualification Structure

The OTHM Level 4 Diploma in Accounting and Business comprises six compulsory units, carrying a total of 120 credits. The qualification requires approximately 1,200 hours of Total Qualification Time (TQT), with a recommended minimum of 600 Guided Learning Hours (GLH).

Mandatory Units

- Academic Writing and Research Skills (20 credits)
- Business and the Economic Environment (20 credits)
- Principles of Financial Accounting (20 credits)
- Quantitative Methods in a Business Context (20 credits)
- Management Accounting (20 credits)
- Leading and Managing Teams (20 credits)

Entry Requirements

These qualifications are intended for individuals aged 18 and above. Applicants should typically meet at least one of the following criteria:

- Possession of a relevant Level 3 Diploma or an equivalent qualification
- Completion of GCE A-levels in two subjects or an equivalent academic achievement

Assessment

All units in this qualification are assessed internally and externally verified by OTHM to ensure quality and consistency. The qualification follows a criterion-referenced framework, meaning learners are evaluated based on their achievement of clearly defined learning outcomes.

Assessment is entirely assignment-based – there are no exams, allowing learners to demonstrate their understanding through practical, coursework-driven tasks.

Progression

Earning the OTHM Level 4 Diploma in Accounting and Business unlocks a wealth of academic and professional opportunities. Graduates can progress to a range of OTHM Level 5 qualifications, including the comprehensive Level 5 Extended Diploma in Accounting and Business.

Carefully structured to support both educational development and real-world career prospects, this qualification is officially approved and regulated by Ofqual (Office of the Qualifications and Examinations Regulation). As such, successful learners may qualify for direct entry into the second year of a UK Bachelor's degree programs, positioning them one step closer to a promising future in the world of finance and business.
